

TERMS AND CONDITIONS OF THE PROMOTION
“Slidesgo Instagram Giveaway”
FREEPIK COMPANY, S.L.U.

1.- Sponsor.

Freepik Company, S.L.U., registered in the Commercial Registry of Málaga, volume 4994, sheet 217, page number MA-113059, with Tax Number B-93183366 and registered office at 13 Molina Lario St., 5th floor, 29015, Málaga, Spain ("Freepik") is the promoter of the present Promotion in accordance with these Terms & Conditions.

2.- Temporal scope of the Promotion

The Promotion shall start on the 28th of September 2022 and end on the 24th of October 2022 at 23:59 h (Spanish time).

3.- Communication elements

The Promotion will be communicated on Slidesgo's Instagram, slidesgo's blog, email and other social media.

4.- Channel

The Promotion is aimed at those interested parties who participate in it through Instagram.

4.- Nature of the Promotion

This Promotion shall be free of charge, in such a way that in order to obtain the prizes it shall not be necessary for the consumer to pay any additional amount, nor shall it imply an increase in the price of the products promoted.

5.- Requirements for participation

Anyone over the age of eighteen (18) with an account on Instagram, except Freepik employees and their immediate family members.

The Promoter reserves the right to require proof of identity from the winners in order to give them the prize. The proof of identification deemed suitable for verification is at the Promoter's discretion. In the event that a winner is unable to provide adequate proof, the prize will be forfeited in full and no substitute will be offered.

6.- Mechanics of the Promotion

To participate, during the Promotion period, as defined below, you must:

1. Follow Slidesgo on Instagram (@slidesgo).
2. Like the Instagram post where the Promotion is announced, which will be published on the Instagram account @slidesgo on 28 of September 2022.
3. Upload a post (reel, image, carousel or video) of your edited Slidesgo template on your Instagram profile, tagging @slidesgo in it.

4. Leave a comment on the announcement post of the raffle that will be published on the Instagram account @slidesgo on 28 of September 2022, with the hashtag #slidesgocontest and mention two friends who would also love to participate (no celebrities nor fake accounts will be considered as a friend).

You can only participate through one Instagram account and only one participation per person will be admitted. If Freepik detects that additional accounts have been used, you will be disqualified.

7.- Deadline for participation.

The period of participation in the Promotion will be from the 28th of September 2022 to the 24th of October 2022 (23:59 h, Madrid, Spain time), inclusive. The Promoter is not responsible for late, lost or misdirected entries due to technical interruptions, network congestion or any other reason.

8.- Prize.

1 annual Slidesgo premium subscription will be awarded to each of the 3 users (which are 3 premium subscriptions in total) who meet the participation requirements and are selected according to the criteria described in section 9 (Winner Selection).

Prizes are non-transferable and cannot be exchanged for money.

9.- Winner selection

Only three participants will be selected as the winners. The winner will be selected randomly through an external tool, between the users that followed the requirements presented on this document. We will also select three reserve persons, in case the winners are unable to collect their prize or do not comply with the terms and conditions of the Promotion.

On the 25th of October 2022, Freepik will communicate the winners on Slidesgo's Instagram account and will contact the winners by sending a private message, in order to formalise the delivery of the prize, as well as to request acceptance of the prizes. The winner will have to confirm their acceptance within one week of sending the private message by the same means, including identification proving that they are of legal age.

If, within the period indicated in the previous paragraph, the prize-winner does not send the required documentation to confirm their interest in receiving the prize, it will be understood that they do not accept the prize and, therefore, renounces them.

In the event that, at the time of being selected as a winner, they have already bought a premium subscription, the prize will begin to apply once the subscription they have taken out has expired.

10.- Expiry date for claiming prizes

The deadline for the winner to claim the delivery of the prizes that have corresponded to them will expire on the 01st of November 2022, provided that they comply with all the requirements established in these Terms and Conditions.

11.- Intellectual property.

The participants acknowledge and agree that by entering this Promotion they are not acquiring any rights over Freepik's intellectual property rights, trademarks or analog rights.
